The National Department of Transport has gazetted the long-awaited National Land Transport Amendment Act and the Amended Regulations, for implementation of **ECONOMIC REGULATION OF TRANSPORT ACT 6 OF 2024**

The Act ushers in a new type of service, e-hailing service, as an additional choice of transport for the traveling public.

- **Transport gazettes National Land Transport Amendment Act and regulations on e-hailing services**
- E-hailing drivers have been given 180 days to meet new requirements under the amended National Land Transport Act, which recognizes e-hailing as a legal mode of public transport.
